


Entry Requirements

- Master's degree or equivalent in relevant discipline from an approved university / institution with at least 55% marks or a minimum CGPA / CPI of 6 on a 10-point scale or an equivalent grade 'B' wherever grading system is followed
- Valid score of Avantika Research Test(ART), an entrance test in line with UGC guidelines
- Proficiency in English

Note: • Students with valid UGC-NET (including JRF) / UGC-CSIR NET (including JRF) / SLET / GATE / Teacher Fellowship Holder or who have passed M.Phil program are also eligible for PhD Admission at Avantika University.

- Part-time PhD will be allowed provided all the conditions mentioned in the extant PhD regulations are met.
