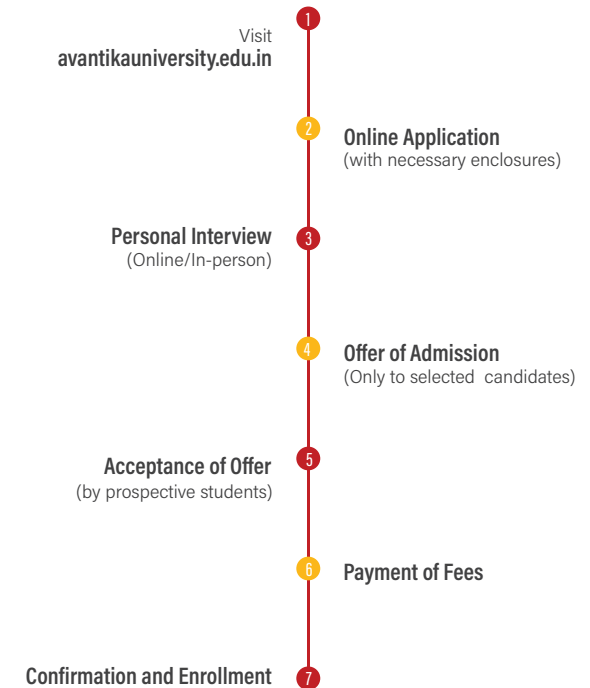
Ph.D

Entry Requirements

- Master's degree or equivalent in relevant discipline from an approved university / institution with at least 55% marks or a minimum CGPA / CPI of 6 on a 10-point scale or an equivalent grade 'B' wherever grading system is followed
- 1 year / 2 year Master's degree or Equivalent from an approved university / institute with at least 55 % marks in aggregate
- Valid score of Avantika Research Test (ART), an entrance test in line with UGC guidelines
- Proficiency in English

Note : • Students with valid UGC-NET (including JRF) / UGC-CSIR NET (including JRF) / SLET / GATE / Teacher Fellowship Holder or who have passed M.Phil. program are also eligible for Ph.D Admission at Avantika University based on interview.
• Part-time Ph.D will be allowed provided all the conditions mentioned in the extant Ph.D regulations are met.
